The Creswell Town Board of Commissioners met on Monday at 7:00 p.m. with the following members present: Mayor Edwin Blount, Commissioner/Mayor Pro Tem Ronald Ambrose, Commissioner Brenda Logan and Commissioner Joel Harris. Commissioner Syble Spruill was not present.

Commissioner Logan provided the invocation.

Commissioner Ambrose led the Pledge of Allegiance.

Commissioner Logan moved to approve the minutes and waive the reading of the September meeting(s). Commissioner Ambrose seconded the motion and it carried unanimously.

New Business:
